It is our pleasure to announce that the **2008 STUTZ ARTISTS OPEN HOUSE** will again be the Art & Cultural event of the year in Indianapolis. All **Artists** and **Businesses** who lease space in the Historic STUTZ Buildings are invited to participate in this exciting event. The following rules for entry and participation will be strictly observed:

1. **If you are an ARTIST** and plan to exhibit, you must agree to be open Friday Night (**5:30 PM – 11:00 PM**) and Saturday (**NOON to 5:00 PM**). We will be promoting Saturday as a Family Day and children under 16 will be admitted free with an adult presenting a paid ticket. Our plan is to double attendance on that day.
2. **If you are a BUSINESS**, you have a choice to open on Saturday. If you have any employees/artists who have paid their fee for the event, your business must be open that day and they must exhibit during the hours as listed above.

An application is available for download on the website (<http://www.stutzartists.com>) and we ask that you complete and return it as quickly as possible so we can make the necessary plans for security, volunteer services and for you to be included in the show program. The application includes all the entitlements you will receive as a paid participant in the event. Applications must be received by March 15, 2008, **to be included in the program** and by April 15, 2008 if you want to be in the show but don't mind if you are not in the program. **Fee payment must be included with the application.**

ENTRY FEES FOR STUTZ ARTISTS ASSN - SPRING OPEN HOUSE TOUR

Artists Who Lease Studio Space

\$100.00 Ea.

The artist who leases space must pay for themselves, if they decide to participate in the Open House.

Artists Who Share or Sublease Studio Space

\$100.00 Ea.

Any artist who co-lease or sub-lease space from the primary artist must pay for themselves, should they decide to participate in the Open House.

Businesses Who Lease Space

\$100.00 Ea.

Any Business who leases space in the building must pay to be open and can sell any art at the show that is done by the owners of the business.

Artists Who Are Employees of Businesses that Lease Space

\$100.00 Ea.

- Any employee who works for the business or sub-leases space from the primary Business owner and would like to exhibit their artwork during the Open House must pay an additional participation fee, should they decide to display/sell their art in the Open House.
- These employee/artists must be identified to the Stutz Artists Association Show Committee at time of application and the Business must be a paid participant in the Open House, in order for the employee/artist to participate.

ARTISTS NOT IN THE BUILDING, WHO DO NOT LEASE, SUB-LEASE, CO-LEASE, OR DO NOT WORK FOR A BUSINESS IN THE BUILDING, MAY NOT EXHIBIT IN THE OPEN HOUSE. THERE ARE NO EXCEPTIONS!
